### **Foreword**

Dear Member,

Orkney's naval past is very much in the spotlight at the moment. However its future as a local hydrogen economy is also firmly in focus, with the recent launch of the 'BIG HIT' hydrogen project. This major EU-funded project builds on the CES-led Surf 'n'Turf project which is creating an opportunity for the communityowned wind turbine on Eday to generate power which would otherwise be impossible owing to the constraints on the Orkney grid. BIG HIT extends this idea to include local members **Shapinsay Development Trust** along with existing partners **EMEC**, ITM Power, Orkney Islands Council and Orkney College and new partners from elsewhere in Europe. Surf 'n' Turf, funded through the Scottish Government's Local Energy Challenge Fund is progressing well. Our other LECF project, ACCESS, in partnership with Mull and Iona Community Trust in Argyll, is similarly enabling the Garnony Hydro to meet its generating potential in a gridconstrained area by linking output directly to local heating requirements. We've also just launched a new partnership project in Edinburgh, 'Tower Power', with our local charity partner, **Comas**, More on this soon! Whilst there is continuing uncertainty on support for renewables at UK level, our community partnership model is working well and is helping communities to find new routes to developing their energy projects. Community Energy Scotland plays a key role in helping set up these partnerships and we are keen to continue to bring community

and industry partners together for the benefit of community projects. Read more below.

## Members' News

#### BIG HIT for Orkney hydrogen!

The BIG HIT project in Orkney stands for 'Building Innovative Green Hydrogen Systems in an Isolated Territory' and is an EU-funded Horizon 2020 joint project. The project, led by Aragon Hydrogen Foundation in Spain, sees us partner community member, Shapinsay Development Trust, and other partners, EMEC, Orkney Islands Council, as well as Scottish Hydrogen Fuel Cell Association, ITM (UK) and a number of international partners. The BIG HIT launch took place in Kirkwall recently and welcomed partners from seven European countries, meeting face-to-face for the first time and hearing how community-owned renewables can

produce clean hydrogen for road transport and heating public buildings. BIG HIT is funded through  $\in$ 5m (around £4m) from the European Commission's <u>Fuel Cell and Hydrogen Joint Undertaking</u>. Its aim is to install and demonstrate the viability of a supply chain for hydrogen in an island territory. Many of the technical challenges in making hydrogen from renewable electricity have already been overcome by <u>Surf 'n' Turf</u>, a project in which CES is leading, and has already attracted Scottish Government investment of £1.2m.

# All Energy 2016

Our team was out in full force at the SECC Glasgow for <u>All Energy 2016</u> in April where we led a lively session on Local Energy Economies. Over the two days, staff were on hand at our exhibition stand to discuss our ongoing work and explore new opportunities to support communities in Scotland.

## A Malawi-Scotland "Eigg's-change"

Thanks to the Arkleton Trust, Morton Kaunda, Edgar Bayani and Harriet Chiwaula from Community Energy Malawi spent a week in Scotland on a learning exchange visit. Georgy Davis from Community Energy Scotland and Steve Evison, board member of the Arkleton Trust joined them on their visit.

The main focus of their trip was to learn from the community-owned and operated mini-grid on the Isle of Eigg. Renewable energy systems, such as Eigg's, have huge potential in a country such as Malawi, where less than 10% of the population have access to mains electricity.

They visited Eigg Primary school, twinned with a school in Malawi, where they met staff and pupils. The Malawi school has recently been affected by severe flooding and so Eigg Primary pupils are currently raising funds to allow the school in Malawi to buy food. The pupils had lots of interesting questions for the Malawian delegation and were even treated to a rendition of the national anthem of Malawi!

The visitors also met Maggie Fyffe of Isle of Eigg Heritage Trust's and John Booth who managed the island electrification project and were taken round to see the wind, solar and hydro developments, together with Eddie who is part of Eigg Electrics maintenance team.

## We're launching our new Energy Monitoring Service

We have previously been involved in two energy monitoring projects, one in partnership with CES member, Hebridean Housing Partnership, and the other in partnership with Albyn Housing Association, both funded through the Scottish Federation of Housing Association's (SFHA) Energy Ideas Fund.

Using lessons learnt from these projects, we are now able to offer an **Energy Monitoring** package, tailored to the needs of each community group. Key work items involved in this package may include sourcing project funding, engaging your community, specifying sensor hardware and installation, collecting and analysing data and providing individual reports, as well as tailored energy advice or signposting to other relevant organisations.

We have developed this tool to automatically generate household reports from a specific set of data and this can be downloaded <u>free from our website</u>. Although the tool was developed to suit the specific requirements of the projects we carried out, we can adapt as required for different projects. #### Good attendance at OWL school

CES staff, Kirsten Macdonald and Ian Garman, ran a successful 'OWL School', taking community members, Barra & Vatersay Community group through the process of how to install and set up the energy monitoring devices. The meters,

funded through CARES IIF, will measure electricity use in houses in Vatersay over the coming months and enable local residents to better understand their electricity use, helping them to reduce their bills where possible, or to see how their energy could be used more efficiently. The training was successfully delivered remotely to the Barra & Vatersay group via Skype, with Ian instructing from Orkney and Kirsten in Stornoway.

### Hoprigshiels: laying foundations for our future

Progress on our own trading arm's joint venture wind project with Berwickshire Housing is continuing apace. A joint site visit by the boards of the two partners took place recently to the windfarm site in the Borders. Norrie Cruickshank, Triodos Bank, the main project funder, also attended. After a safety briefing and update from the site agent, board members could see that access roads, parking bays and turning heads were largely complete, along with foundation excavations at the two turbine sites. Work was also progressing on the main substation building with the roof almost complete. The turbine delivery date was confirmed

for early September and, subject to weather conditions, the turbines should be complete and ready to connect by early November. The plan is to have the turbines in operation before the year end.
